1 Pursuant to the Stipulation for Entry of Judgment by and between Plaintiff,
2 Ford Motor Credit Company LLC (“Ford Credit”), and Defendants, Wilhelm &
3 Associates, Inc., dba Norco Mazda (“Norco Mazda”) and Jeff D. Wilhelm
4 (“Wilhelm”), and for good cause appearing therefor,

5 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that,

6 1. Plaintiff, Ford Credit, is awarded and shall recover the sum of \$974,000
7 (nine hundred seventy four thousand dollars) against Defendant, Norco Mazda.

8 2. Plaintiff, Ford Credit, is awarded and shall recover the sum of \$400,000
9 (four hundred thousand dollars) against Defendant, Wilhelm.

10 3. Ford Credit shall not execute upon this judgment for a period of one
11 hundred and eighty (180) days from the date of entry.
