28 CHANGES MADE BY COURT

1 Pursuant to the terms of the Protective Order submitted by Plaintiff United
2 States and Defendant Union Auto Sales, Inc., IT IS SO ORDERED with the
3 following modifications (changes in bold):

4 1. Paragraph 2 is modified to read as follows:

5 Documents or information designated as “Confidential” shall be used
6 solely for purposes of the prosecution and/or defense of this action.

7 **Unless otherwise ordered by the Court**, all persons identified in
8 Paragraph 3 who are given access to any document(s) or information
9 designated as “Confidential” **and all persons to whom access to any**
10 **document(s) or information designated as “Confidential” is afforded**
11 **pursuant to Paragraph 4** are prohibited from disclosing to or otherwise
12 discussing such document(s) or information with any other person except
13 as specifically provided below.

14 2. Paragraph 5 is modified to read as follows:

15 In the event that any document or information **designated as**
16 **“Confidential”** is the subject of witness examination at a deposition
17 **[language deleted]** held in connection with this case, the person claiming
18 the matter consists of, or contains, Confidential Information shall note on
19 the record that all examination and testimony pertaining thereto shall be
20 considered confidential and the pages of any transcript thereof so
21 designated. **In the event that any document or information**
22 **designated as “Confidential” is the subject of witness examination at**
23 **a hearing, trial, or other proceeding held in connection with this**
24 **case, other than a deposition, a person claiming the matter consists**
25 **of, or contains, Confidential Information who seeks to limit public**

1 **access thereto at such hearing, trial, or other proceeding, shall make**
2 **any requests to limit public access thereto to the presiding judge.**

3 **IT IS SO ORDERED.**
