1. Preliminarily enjoined and restrained pending trial from:

(a) Directly or indirectly infringing in any manner any right in any and all copyrighted works (or portions thereof), whether now in existence or later created, in which any Plaintiff (including its parents, subsidiaries, affiliates, or distributed labels) owns or controls an exclusive right under Section 106 of the United States Copyright Act (17 U.S.C. § 106) (the "Copyrighted Sound Recordings"), including without limitation by directly or indirectly copying, reproducing, downloading, distributing, communicating to the public, uploading, linking to, transmitting, publicly performing, or otherwise exploiting in any manner any of Plaintiffs' Copyrighted Sound Recordings (including but not limited to those set forth in Schedule A to the Complaint), whether through the websites www.bluebeat.com, www.basebeat.com, or otherwise; and

Directly or indirectly infringing in any manner any right in any (b) and all sound recordings originally fixed in a tangible medium of expression prior to February 15, 1972, in which any Plaintiff (including its parents, subsidiaries, affiliates, or distributed labels) owns or controls an exclusive right or under state or common law (the "Pre-1972 Sound Recordings"), including without limitation by directly or indirectly copying, reproducing, downloading, distributing, communicating to the public, uploading, linking to, transmitting, publicly

1	performing, or otherwise exploiting in any manner any of Plaintiffs' Pre-1972
2	Sound Recordings (including but not limited to those set forth in Schedule B to the
3	Complaint), whether through the websites <u>www.bluebeat.com</u> , <u>www.basebeat.com</u> ,
4	or otherwise.

6	Plaintiffs shall not be required to post a bond upon the issuance of this
7	Preliminary Injunction.
