22 attacks while sleeping with NO police assistance and NO hotel offered),
23 CA Penal 647(a) - (Failure to take to a real homeless shelter and abuse
24 of Jail as a shelter), CA Penal 647(c) - (Obstruction of justice process -
25 including food tampering, stalking, and defecation by restaurant and
26 store owners with NO discounts and NO disability accom.),
27 CA Penal 365.5 (Disorderly Acc - left homeless) obstructing recovery),
28 CA Penal 694 (Denial of self Defense), CA Penal 629.50 et seq


