25 Pursuant to the Stipulation of the Parties and

26 FOR GOOD CAUSE SHOW,

27 IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

1 Plaintiff and Defendant Carlton Books, Ltd. ("Carlton") have stipulated that Plaintiff
2 shall have judgment on the Complaint. Judgment in this action shall enter as follows:

3 1. Conan Properties International LLC ("CPI") owns rights, title and interest to the
4 following stories protected by United States copyright registrations: "Black Colossus" (reg.
5 no. B 211 038; renewal no. R 269 994), "Phoenix on the Sword" (reg. no. B 175 731;
6 renewal no. R 250 145), "Pool of the Black One" (reg. no. B 211 042; renewal no. R 269
7 998), "Rogues in the House" (reg. no. B 246 430; renewal no. R 270 001), "Scarlet Citadel"
8 (reg. no. B 175 732; renewal no. R 250 146), "Slithering Shadow" (reg. no. B 211 041;
9 renewal no. R 269 997), "Tower of the Elephant" (reg. no. B 211 035; renewal no. R 269
10 991).

11 2. Carlton is enjoined from selling in and/or importing into the United States any books
12 (including, but not limited to the book entitled *Conan the Barbarian*), containing the above-
13 referenced Robert E. Howard stories for the remainder of the terms of copyright in the
14 stories, except by license.

15 3. Among the many worldwide trademark registrations CPI owns in connection with the
16 Conan intellectual property, CPI owns United States trademark registration numbers
17 1374714, 3607668, and 2522082 in Class 16 for the mark CONAN; and United States
18 trademark registration number 2522083 in Class 16 for the mark CONAN THE
19 BARBARIAN.

20 4. Carlton is permanently enjoined from selling in and/or importing into, the United
21 States any books which utilize the above-referenced trademarks in their titles, except by
22 license.

23 Therefore, pursuant to the foregoing stipulations;

24 IT IS ORDERED that judgment enter for Plaintiff on the Complaint. The Parties shall each
25 bear its own costs and attorneys fees in this matter.
