Mr. Eppes,

I am general counsel to Xcentric Ventures, LLC which operates the website <a href="www.RipoffReport.com">www.RipoffReport.com</a>. I have received and reviewed your letter dated November 24, 2009 which requests the removal of this report: <a href="http://www.ripoffreport.com/drunk-drivers/">http://www.ripoffreport.com/drunk-drivers/</a>

I understand from your letter (and the two rebuttals posted to this report) that the report involves a person who died in 2008. I further understand that the concerns raised in your letter primarily relate to the fact that the decedent's teenage daughter (who shares his unusual surname) is having trouble when people perform a Google search for her and then find the story on Ripoff Report about her father.

In light of these concerns, I have several comments.

First, as a general rule, Ripoff Report does not remove reports. There are numerous factual and legal reasons for this policy explained on our website here:

http://www.ripoffreport.com/ConsumersSayThankYou/WantToSueRipoffReport.aspx Indeed, we have spent millions of dollars in legal fees over the past several years defending our users' rights to post comments, and to date we have never lost a case. As such, we are generally not willing to serve as the arbiter of disputes over the accuracy of a report.

Second, although we generally are unwilling to remove or redact reports, we always have the editorial discretion to do so. In this instance, while we are not willing to remove the original report, we believe that Mr. daughter should not be punished for mistakes her father may have made during his life. As such, and in keeping with the Christmas spirit, we are willing to help as follows – we are willing to partially redact the report by removing the name " . This would hopefully mean that anyone searching for should not see the report in the search results.

If this is acceptable to you, please let me know and this change can be made within a few days.

Finally, though it goes without saying, this offer should not be construed as an admission that we are under any obligation to change or remove this report. On the contrary, we firmly believe that we are under no legal obligation to make any such changes. However, there are times when the requirements of law are secondary to moral obligations, and in this case, we believe that making a rare exception to our general rule is a reasonable thing to do.
