1 WHEREAS Defendant Google Inc.'s ("Google") existing deadline to respond  
2 to the Complaint is June 1, 2010;

3 WHEREAS on May 28, 2010, during a status conference in which the Court  
4 denied Plaintiff's *ex parte* application for a temporary restraining order and  
5 preliminary injunction, the Court instructed the parties to discuss whether a resolution  
6 of this litigation was possible;

7 WHEREAS the parties subsequently held such discussions and are attempting  
8 in good faith to see if a resolution is possible, and the parties believe that extending  
9 Google's existing deadline to respond to the Complaint would increase the possibility  
10 of such resolution;
