9 6. Google Inc. a California corporation website www.blogspot.com and the attachments, additions
10 and other associated links on: www.michaeledelsteinslandercampaigns.blogspot.com modify
11 Michael Edelstein's copyrighted image, with malicious intent, employing false copyright
12 management information, with law enforcement identification, concealing valid copyright
13 information, with authors copyrighted image. Further, placing authors, copyrighted image with
14 libelous postings to injure, annoy, hinder and harass plaintiff, finding gainful employment and
15 injuring plaintiffs reputation causing plaintiff damage and distress, on the Internet with a viewership
16 of millions daily with with such statements as: "We have an overwhelming response to our warnings
17 about employing mentally unstable Michael Edelstein. It turns out that when he applies for work
18 (remember he does so only to later either extort money from his employers or steal from them or
19 both). Michael Edelstein has been released from his latest stretch in prison, Michael Edelstein has
20 served time for lewd conduct, attempting sexual battery, transmitting harmful materials to a minor,
21 An Internet Fraudster and Vicious Lunatic, Michael Edelstein is wanted by Interpol in Germany."
22 Also various titles such as: "THINKING OF EMPLOYING MICHAEL EDELSTEIN, THE
23 HIDEOUS FACE OF AN INTERNET SLANDERER - MICHAEL EDELSTEIN, MICHAEL
24 EDELSTEIN'S LATEST DISGUISE, YOU MIGHT BE THE NEXT VICTIM."

1 7. The website www.blogspot.com owned and administered by Google Inc. is causing plaintiff
2 hatred, contempt, ridicule, obloquy, in that Michael Edelstein's copyrighted image has intentional
3 distortion and modification, and other derogatory actions would be prejudicial to his honor or
4 reputation with malicious intent, providing false management information. Plaintiffs copyrighted
5 image was removed from YouTube.com and then appeared on Google Inc. website:
6 michaeledelsteinsslandercampaigns.blogspot.com in January 2009. Authors copyrighted image
7 was enlarged and altered with digital photographic software, a sign was added under plaintiffs chin:
8 "West Palm Beach Sherifs Office 92 FLO 000000," providing copyright management information
9 that is false, intentionally removing copyright management information of author Michael
10 Edelstein's copyrighted blog and image www.theweinerbrothersvptour.com. EXHIBITS A, B, C, D.

11 8. Michael Edelstein produced a video blog, created on plaintiffs computer web camera and
12 uploaded to YouTube: written, directed and produced by Michael Edelstein from a blog Michael
13 Edelstein had written and posted on Blogspot: www.theweinerbrothersvptour.com. The Weiner
14 Brothers blog (internet log or diary) detailed Michael Edelstein's personnel experience: working at
15 the Warner Brothers Studio and breaking into entertainment. Copyright and management information
16 was intentionally removed from authors posting on YouTube and replaced with false law enforcement
17 management information on www.blogspot.com. Each video on YouTube displayed a static
18 copyrighted image of author on a series of videos created in 2007, each video is accompanied
19 with this information: "In concept similar to the Twilight Zone a new expose by the master of
20 horror, outlining his research for his new book. The horror continues with a Michael Moore style
21 expose.... <http://theweinerbrothersvptour.blogspot.com> © 2007 copyright by author"

22 Videos created by Michael Edelstein author and copyright holder reads selected pages
23 from his copyrighted work entitled the Weiner Brother VP Tour, recounting authors entry level
24 employment at the Warner Brothers Studio as a guide.
25

1 9. Plaintiff completed two Google Inc. DMCA complaint online removal forms outlining the
2 www.blogspot.com misuse of Michael Edelstein's copyrighted image with no success on 2.22.10
3 and 2.23.10. A different copyrighted image of plaintiff posted to www.blogspot.com
4 site was removed July 28, 2009. This is the second incident of infringement, over an eight month
5 period. Michael Edelstein has written to Google Inc. numerous detailed emails advising
6 Google Inc. of overt copyright violations of Michael Edelstein's image, the misuse of the image:
7 intentional distortion, false copyright management information, prejudicial to his honor or
8 reputation, and concealing copyright information, other derogatory actions in relation to his
9 work. The malicious intent of the sites to include the use of false law enforcement identification,
10 sign, posting, adapted and altered with plaintiff's copyrighted image, demanding the removal of
11 the copyrighted image and the sites in their entirety.

12 10. Google Inc. has adopted an extremely cavalier attitude and claims per federal statute they are not
13 responsible for content of www.blogspot.com even though Google Inc. owns and administers the
14 www.blogspot.com website. According to Google Inc. www.blogspot.com terms of service regarding
15 repeat offenders:

16 11. *"Many Google Services do not have account holders or subscribers. For Services that do,*
17 *such as Blogger, Google will, in appropriate circumstances, terminate repeat infringers. If*
18 *you believe that an account holder or subscriber is a repeat infringer, please follow the*
19 *instructions above to contact Google's DMCA agent and provide information sufficient for us*
20 *to verify that the account holder or subscriber is a repeat infringer."*

3 12. (Violation of Title 17 U.S.C Copyright Act of 1976: § 106 A,
4 (a), (3), (d) rights of certain authors to attribution and integrity.

6 13. § 106 A. Rights of certain authors to attribution and integrity:

7 (a) Rights of Attribution and Integrity. — Subject to section 107 and
8 independent of the exclusive rights provided in section 106, the author
9 of a work of visual art —

10 (3) subject to the limitations set forth in section 113(d), shall have
11 the right —

12 (A) to prevent any intentional distortion, mutilation, or other modification of that
13 work which would be prejudicial to his or her honor or reputation, and any intentional
14 distortion, mutilation, or modification of that work is a violation of that right, and

15 14. (d) Duration of Rights. — (1) With respect to works of visual art created on or
16 after the effective date set forth in section 610 (a) of the Visual Artists Rights Act of
17 1990, the rights conferred by subsection (a) shall endure for a term consisting of the
18 life of the author.

19
20 15. This is not a fair use criticism, comment, news reporting, teaching (including
21 multiple copies for classroom use), scholarship, or research or audiovisual performance
22 that would be covered under § 107. Limitations on exclusive rights: Fair Use
23 Act. This is also not a work of visual art incorporated in or made part of a building in
24 such a way that removing the work from the building will cause destruction, distortion,
25 mutilation or other modification per § 113 (d).

1 16. Under copyright Law of the United States of America and Related Laws Contained in Title
2 17 of the United States Code, Berne Convention Implementation Act of 1988, § 101, 2, 3. (a), (1),
3 (b), (1), (2), Appendix II Berne Convention Implementation Act of 1988 Sec. 2. Declarations.
4 The Congress makes the following declarations: (3) The amendments made by this Act, together with
5 the law as it exists on the date of the enactment of this Act, satisfy the obligations of the United States
6 in adhering to the Berne Convention and no further rights or interests shall be recognized or created

14 (1) provide copyright management information that is false, or

15 (2) distribute or import for distribution copyright management information that is
16 false.

18 22. (b) Removal or Alteration of Copyright Management Information. — No person
19 shall, without the authority of the copyright owner or the law —

21 23. (1) intentionally remove or alter any copyright management information,

22 (2) distribute or import for distribution copyright management information
23 knowing that the copyright management information has been removed or
24 altered without authority of the copyright owner or the law.

Request for Relief

WHEREFORE, the plaintiff requests:

24. Compensatory damages including general, actual, statutory and punitive damages according to proof under § 504 and § 1203. Remedies for infringement. I am seeking punitive damages under California State Civil Code § 3294 for malice and oppression.

25. I am seeking immediate injunctive relief under Title 17 U.S.C. § 502 (a). Remedies for infringement: Injunctions, removal of plaintiffs copyrighted image on Google Inc., blogspot.com websites to include attachments, additions and other associated links as well as the libelous content of the site be removed permanently at:

26. (a) Any court having jurisdiction of a civil action arising under this title may, subject to the provisions of section 1498 of title 28, grant temporary and final injunctions on such terms as it may deem reasonable to prevent or restrain infringement of a copyright.

27. (a) Any such injunction may be served anywhere in the United States on the person enjoined; it shall be operative throughout the United States and shall be enforceable, by proceedings in contempt or otherwise, by any United States court having jurisdiction of that person. The clerk of the court granting the injunction shall, when requested by any other court in which enforcement of the injunction is sought, transmit promptly to the other court a certified copy of all the papers in the case on file in such clerk's office.

2 28. I am seeking immediate injunctive relief and damages under Title 17 of the United States Code
3 § 1203 (1). I am demanding per the Digital Millennium Copyright Act that plaintiffs copyrighted
4 image be removed from Google Inc., www.blogspot.com websites to include attachments, additions
5 and other associated links at:



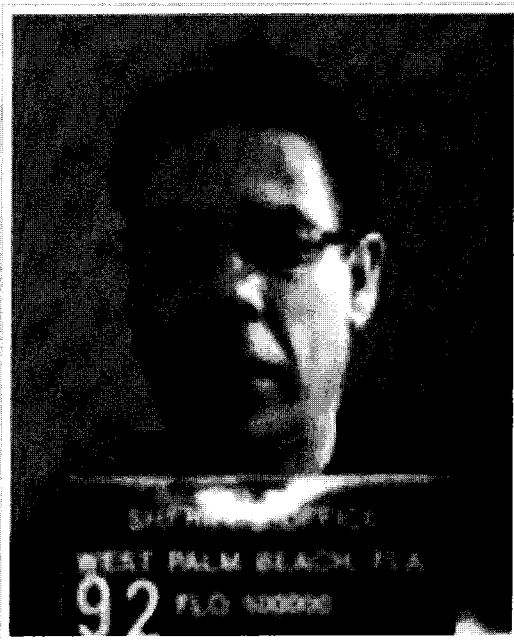

have known him in Poland and in Hungary are adamant that he barely speaks a few words of either language, and one German speaking former employer stated that “Edelstein didn’t even know what the word ‘Gesundheit’ meant.”

Edelstein also claims to have attended “Graduate School of Radiologic Technology,” but the closest thing he came to that was working as a janitor at an LA hospital. It was at this children’s hospital where he was fired for “inappropriate touching” of an underage child. This compulsive liar also often claims that he has an “Associate Arts Degree, Theater Arts” and a “Bachelor of Arts Degree, Communications” – both of which are entirely untrue.


Edelstein also claims to have his own 30 minute classic rock radio show on KCLAFM.com and that he co-hosts a one hour talk radio show on KLAS FM. Contact either one of these stations, and you will be told that neither of them have ever heard of Michael Edelstein!

His resume also includes “working as an on-site courier for Warner Brothers” – he briefly worked as a summer part-time tour guide and was fired for stealing and inappropriate behaviour. He then set out to defame Warner Brothers by flooding the internet with slander – just Google “Wiener Brothers” and you will find countless pages of defamatory material that he has posted. He often uploads posts on YouTube as well, claiming that he is the famous author Steven King, and slanders Warner Brothers and many other companies and individuals.

Edelstein will tell you that he “Owned several on-line businesses to buy and sell vintage military documents, uniforms, badges and photographs from the period of 1900 to 1945 from Budapest , Hungary.” Numerous people and law enforcement agencies are currently after Edelstein, as he would offer items for sale, collect people’s money, and then never deliver. Every so often he would close one online store, only to open another under an assumed name, and repeat the process.

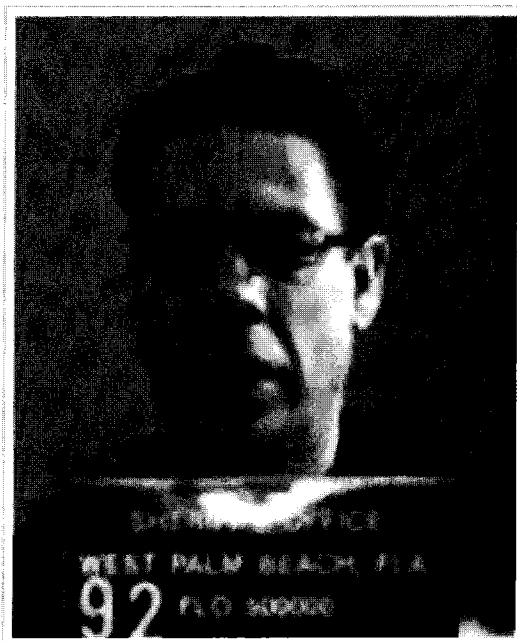
We contacted the Budapest Sun, where he claims to have worked for one year. A representative from that paper told us that he had pestered them for work for several months, and then threatened them that he would publicly declare that they wouldn’t hire him because he was Jewish. He told them that he would not do so if they paid him 10,000 Euros.

Michael Edelstein also claims to be a published author, and that he wrote a book called "Wings of Grace and Valor" on the Austro-Hungarian aviation service and their insignia. After some research we found out that this tome was really a 12 page photocopied booklet plagiarized from a pamphlet from a European war museum, which he used to sell to people for \$45.00.

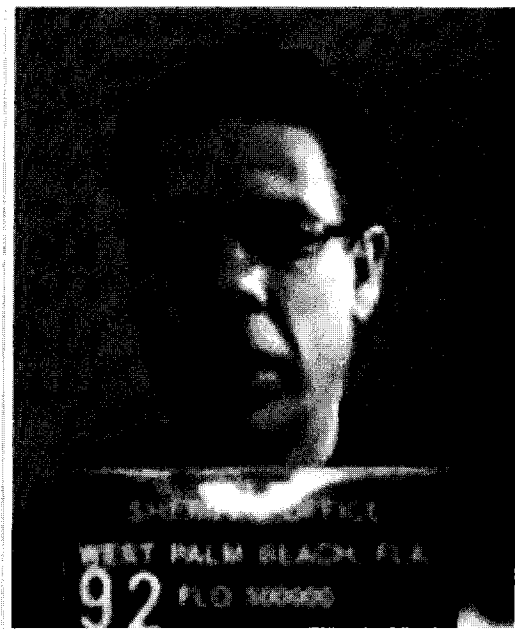

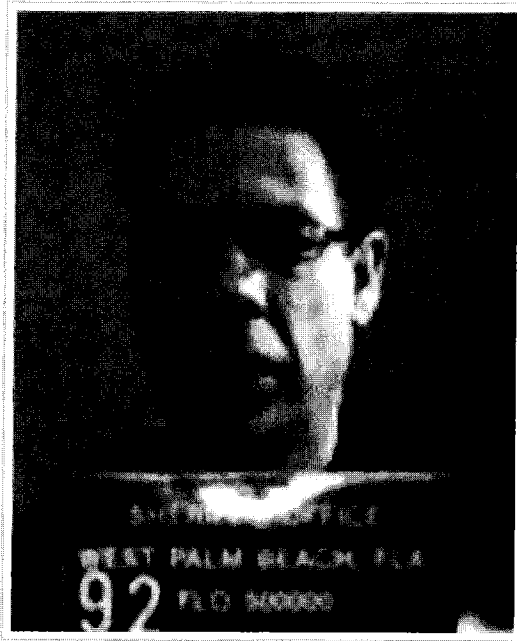

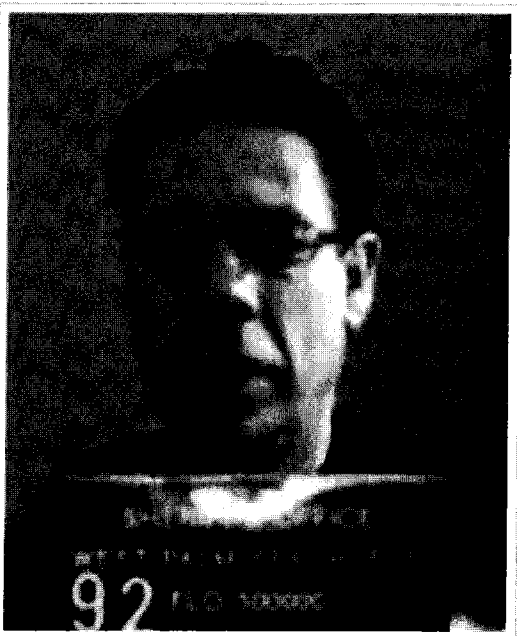

He suffers from acute delusional paranoia which makes him accuse various militaria collectors and dealers of belonging to an "Internet mafia" which supposedly sells fake badges, etc. He is also a compulsive liar and thief.

Van Lauesen/Edelstein's growing notoriety may eventually force him to go underground, or assume a different pseudonym. In this case, watch out for the following telltale signs:

- a general delivery/poste restante address in Budapest or generally in Hungary;
- personal email address ending in "datanet.hu";
- seller mostly offers German, Hungarian, Austrian and Polish militaria;
- seller offers a vanity press publication about the Austro-Hungarian

military aviation badges; - his writing style is full of cheap claque; quite often his spelling is very poor and his sentence structure faulty to the point of gibberish; - his website may contain a number of rambling and progressively more and more incoherent rants about "eScam" (meaning eBay), "Internet mafia", "Hungarian mafia", "vanity page", "totally fleeced", etc.; - he may also post some of his more "normal" texts on the Hungarian 1921 pilot's badge, Austria's highest honor (the Order of Maria Theresa), Austro-Hungarian Naval Air Service 1910-1918, the death's heads (on the Hungarian para badges), etc.

Remember: if you don't want to lose your money and get publicly slandered as well, keep away from this individual! Michael M. van Lauesen is one of the worst creeps on the Net. Please feel free to copy and post this warning wherever you think necessary.
