20 On October 24, 2011, the Court, Honorable John A. Kronstadt, United States
 21 District Court Judge Presiding, held a hearing on the following motions: (1)
 22 Plaintiff’s Motion for Summary Judgment (Docket No. 42) filed by Plaintiff
 23 George Hernandez, (2) Defendants City of West Covina and Frank Wills’ Motion
 24 for Summary Judgment or, in the alternative, Summary Adjudication (Docket No.
 25 44), and (3) Defendant Tyler Kennedy’s Motion for Summary Judgment or, in the
 26 alternative, Summary Adjudication (Docket No. 48). All the cross-motions for
 27 summary judgment addressed all the claims and causes of action contained in
 28 Plaintiff’s Second Amended Complaint.

1 The arguments having been presented and fully considered, and in
2 accordance with the Court's November 22, 2011, Minute Order granting Summary
3 Judgment in favor of Defendants City of West Covina and Frank Wills:

4 It is therefore now ORDERED, ADJUDGED, and DECREED that judgment
5 is entered in this action as follows:

6 1. Plaintiff George Hernandez ("Plaintiff") shall recover nothing from
7 Defendants City of West Covina and Frank Wills;

8 2. Defendants City of West Covina and Franks Wills shall have
9 judgment in their favor against Plaintiff; and,

10 3. Defendants City of West Covina and Franks Wills shall recover from
11 Plaintiff their costs of suit.
