1 I, Pamela Vaughn, declare:

2 1. I am the Postmaster of the United States Post Office in Conifer,
3 Colorado. I am over eighteen years of age and have personal knowledge of the
4 facts set forth herein and could and would testify competently about them.

5 2. Official Post Office records show that on February 11, 2011 Certified
6 Mail Item number 70103090009371145508 (the "Item") was delivered to the
7 Conifer Post Office. The Post Office's certified mail Delivery
8 Notice/Reminder/Receipt (PS Form 3849) (the "Delivery Notice") was left for the
9 Item in Post Office Box No. 392. Post Office Box No. 392 is registered to Global
10 Equities, LLC and David Figuli. In addition Mr. Figuli authorized his spouse Laura
11 Figuli to receive mail at this Post Office Box.

12 3. On February 15, 2011, at approximately 12:27 p.m., one Hilarie
13 Anderson presented the Delivery Notice to our Post Office Staff, signed the
14 electronic receipt pad and the Item was provided to her. A true and correct copy of
15 the signed electronic receipt is attached hereto as Exhibit 1.

16 4. The Post Office maintains the security of our post office boxes by
17 presenting the registered renter with one key unless the renter purchases a duplicate.
18 In this case, Post Office records show that Global Equities, LLC and David Figuli
19 were issued two keys.

20 I declare under penalty of perjury under the laws of the United States of
21 America that the foregoing is true and correct. Executed this 25th day of March,

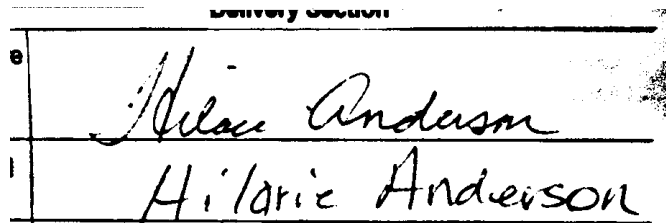
