I, Stuart Sorensen, declare:


- 1. I am over the age of eighteen and a Civil Process Server and Deputy Sheriff in Jefferson County, Colorado. I am not a party to this action. I have personal knowledge of the facts stated in this declaration and, if called as a witness, could and would testify competently about them.
- 2. During the period between November 8 and December 20, 2010, I made eight attempts to personally serve defendants David J. Figuli and Global Equities, LLC d/b/a Higher Education Group (collectively, "Defendants") with the following documents: (i) Complaint for Injunctive Relief and Damages in this action; (ii) the Summons issued by the Court; (iii) Civil Cover Sheet, (iv)Notice of Assignment to Magistrate Judge for Discovery; (v) Notice to Parties of ADR Program; (vi) Certification and Notice of Interested Parties; and (vii) the Court's Standing Order Regarding Newly Assigned Cases. The foregoing seven documents are collectively referred to as the "Service Documents." Copies of the face pages of the Service Documents are attached hereto as Exhibit A for the Court's convenience. My specific attempts to serve the Defendants are set forth below.
- 3. Plaintiff's counsel provided me with what counsel believed was Mr. Figuli's address in Evergreen, Colorado for his law firm. I attempted service on Monday, November 8, 2010, at approximately 4:40 p.m., by going to the address provided by counsel, namely, 29713 Troutdale Scenic Drive, #C-2, Evergreen, Colorado, 80439. I was told by a receptionist that Mr. Figuli's law firm had moved and that another law firm was now occupying the space.
- 4. Plaintiff's counsel provided me with the Defendants' addresses representing that the addresses were obtained from the Web sites of the Colorado Secretary of State and the State Bar of Colorado. The address for both Defendants is 8697 S. Blue Creek Road, Evergreen, Colorado, 80439 ("Blue Creek Road")

- 5. On Tuesday, November 9, 2010, at approximately 5:00 p.m., I went to the Blue Creek Road address. I found a locked electric gate with no intercom in a wooded, hillside area. I waited for several minutes, but did not see anyone arrive or depart.
- 6. On Wednesday, November 24, 2010, at approximately 1:25 p.m., I went to the Blue Creek Road address. I waited for several minutes, but did not see anyone arrive or depart.
- 7. On Monday, November 29, 2010, at approximately 6:15 p.m., I went to the Blue Creek Road address. I waited there for several minutes and did not see anyone arrive or depart. Plaintiff's counsel had also provided me with a telephone number for Mr. Figuli, namely, 720-810-2495. That telephone number is reflected on the Colorado Supreme Court's record (Exhibit B). On November 29, 2010, I called Mr. Figuli at the telephone number and his voicemail picked up. The message stated that it was Mr. Figuli and I left him a message identifying myself, the purpose of my call and requesting a return call. I never received a return call.
- 8. On Wednesday, December 8, 2010, at approximately 11:10 a.m., I went to the Blue Creek Road address. I waited there for several minutes, but did not see anyone arrive or depart.
- 9. On Tuesday, December 14, 2010, at approximately 4:00 p.m., I went to the Blue Creek Road address. I waited there for several minutes, but did not see anyone arrive or depart.

- 10. On Wednesday, December 15, 2010, at approximately 11:30 a.m., I went to the Blue Creek Road address. I waited there for several minutes, but did not see anyone arrive or depart.
- 11. On Monday, December 20, 2010, at approximately 5:20 p.m., I went to the Blue Creek Road address. I waited there for several minutes but did not see anyone arrive or depart.
- 12. In May and June of 2009, I previously attempted service of process on Mr. Figuli by making multiple attempts at the Blue Creek Road address. This was for a different attorney than plaintiff's counsel in a case that is unrelated to this case. I was unable to serve Mr. Figuli personally or another person at the Blue Creek Road address in those previous attempts.


