1 WHEREAS, the parties previously stipulated to an extension of time for
2 Defendants to respond to the Complaint, providing that Defendants' response was
3 due January 24, 2011 and Defendants filed their motion to dismiss on that date
4 (Doc. 16); and

5 WHEREAS, as part of the meet and confer process prior to the filing of its
6 motion to dismiss, Defendants and Plaintiffs discussed the hearing date and
7 briefing schedule for the motion; and

8 WHEREAS, in light of the extension of time agreed to by Plaintiffs for
9 Defendants to respond to the Complaint, Plaintiffs requested additional time to
10 oppose Defendants' motion to dismiss beyond that provided in the Local Rules, to
11 which Defendants agreed; and

12 WHEREAS, Plaintiffs' agreed to Defendants' request to have two weeks to
13 reply to Plaintiffs' opposition brief; and

14 WHEREAS, the parties are informed that the next available motion hearing
15 dates are March 14, March 21, April 4, and April 11; and

16 WHEREAS, counsel have conflicts on March 21, April 4 and April 11 and
17 therefore set the hearing on Defendants' motion to dismiss for March 14, 2011 at
18 11:00 a.m.; and

19 WHEREAS, the parties understand that under Local Rule 7-10 reply papers
20 are due 14 days prior to the hearing and request leave to allow the Defendants to
21 file reply papers seven days prior to the hearing; and

22 WHEREAS, therefore the parties agree and respectfully propose to the Court
23 that Plaintiffs' opposition be due on February 21, 2011, and Defendants' reply be
24 due March 7, 2011;

25 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED that
26 the hearing and briefing schedule on Defendants' motion to dismiss be as follows:


- 27 1. Plaintiffs' opposition will be due February 21, 2011.
