24 **DECLARATION OF ROBERT J. ALLAN**

25 I, ROBERT J. ALLAN, declare as follows:

26 1. I reside in Los Angeles County and am over eighteen years of age. I
27 am the founder and managing shareholder of Allan Law Group, PC ("ALGPC"),
28 a law firm located in Malibu, California. I have personal knowledge as to the

1 facts set forth in this declaration, except as to those which I state on information
2 and belief, and as to those facts, I believe then to be true. I am admitted to
3 practice law in California and in the Central District Court of California.

4 2. ALGPC represented plaintiff George Clinton on a number of legal
5 matters from approximately January 2010 until July 2011. Some of the general
6 categories of representation include general business affairs, licensing, and
7 litigation.

8 3. The litigation matters for which ALGPC represented Mr. Clinton
9 included a lawsuit entitled Wlodinguer & Erk, CPA's PLLC, as successor-in-
10 interest to Wlodinguer, Erk & Chanzis, CPA's PLCC v. George Clinton, case
11 number 10 CIV 4394 (SHS)(AJP), filed in the United States District Court,
12 Southern District of New York, filed on September 15, 2010. Appearing in pro
13 per, attorneys from ALGPC, including Rod Rummelsburg and me, were the lead
14 counsel. ALGPC ultimately was able to negotiate a settlement and dismissal of
15 the case after being retained days before a default judgment was going to be
16 entered against George Clinton.

17 4. ALGPC's rendered all legal services for Mr. Clinton pursuant to a
18 written engagement letter.

19 5. On November 30, 2010 entered into a contractual lien with ALGPC
20 (the "Contractual Lien"), granting ALGPC a lien on money owed by Mr. Clinton
21 to ALGPC for legal services rendered or to be rendered, such lien applying to
22 recovery from a yet-to-be-filed lawsuit against the musical group The Black-Eyed
23 Peas ("BEP") for infringement of the copyright ownership interest of George
24 Clinton in the master sound recording of "(Not Just) Knee Deep," a/k/a "Knee
25 Deep." A true and correct copy of the Contractual Lien is attached hereto as
26 Exhibit 1.

1 6. On December 1, 2012 I caused to have filed on behalf of ALGPC a
2 UCC-1 Financing Statement with the California Secretary of State to secure the
3 Contractual Lien with a chose-in-action of a lawsuit to be filed against BEP. A
4 true and correct copy of the UCC-1 Financing Statement is attached hereto as
5 Exhibit 2.

6 7. Attached as Exhibit 3 is a true and correct copy of ALGPC's
7 accounting for legal fees ("Pre-Bill Worksheet") incurred on behalf of Mr.
8 Clinton in the lawsuit against BEP. Portions of the Pre-Bill Worksheet have
9 been redacted to preserve client and attorney privileges.

10 8. In total ALGPC spent a total of three hundred ninety-five (395)
11 hours (386.35 billable hours + 8.35 hours at no charge + 0.75 unbilled hours) at a
12 cost of \$115,014 for legal fees. These legal fees were incurred over a period of
13 approximately 16 months.

14 9. Attached as Exhibit 4 is a true and correct copy of ALGPC's costs
15 incurred in the lawsuit against BEP.

16 10. ALGPC incurred \$2,455.30 in costs over 16 month time period in
17 support of legal services on behalf of Mr. Clinton.

18 11. ALGPC spent approximately a month researching the factual basis
19 of the claims and then drafting the complaint ("Complaint") at the end of 2010.
20 ALGPC retained a music expert to determine whether the BEP had "sampled" a
21 sound recording owned by Mr. Clinton.

22 12. Soon after ALGPC filed the Complaint, counsel for the BEP
23 engaged ALGPC in settlement discussions. A settlement was not reached at that
24 time, however, despite multiple discussions.

25 13. ALGPC caused the Complaint to be served to the defendants. In
26 doing so, ALGPC hired a detective to locate one of the defendants. ALGPC
27 advanced the funds for the detective.

14. ALGPC subsequently prepared the Rule 26 Initial Disclosures and coordinated with counsel for the defendants and drafted the Joint Rule 26 Report. ALGPC propounded written discovery and noticed deposition(s) before Mr. Clinton substituted in the firm of Dobrusin & Thennisch PC in place of ALGPC

15. ALGPC was not involved in the mediation giving rise to the current proposal to distribute an advance \$100,000. ALGPC does not agree with the proposed distribution.

I declare under penalty of perjury under the laws of the United States that the forgoing is true.

George Clinton, Case Number 10 Civ. 4394 (SHS) (AJP), filed in the United States District Court, Southern District of New York, filed on September 15, 2010 ("Erk Case");


iv) Mr. Clinton has retained ALGPC to investigate the factual and legal background and basis for the claims in and assist counsel of record in a lawsuit entitled George Clinton v. Universal Music Group, Inc. and UMG Recordings, Inc., case number CV 07-00672 PSG (JWJx), filed in the United States District Court, Central District of California, filed January 29, 2007 ("UMG Case"); and

v) ALGPC is entitled to be paid legal fees from George Clinton for legal services rendered or to be rendered and is further entitled to be reimbursed by George Clinton for ALGPC's out of pocket costs and expenses incurred or to be incurred by ALGPC in connection with providing legal services to George Clinton in GBA Representation, in the Erk Case, and in the UMG Case.

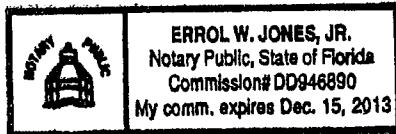
In consideration for ALGPC providing me with legal services for GBA Representation and in the Erk Case and the UMG Case as described in sections ii, iii, and iv above, I, George Clinton, hereby agree to irrevocably assign any and all money due to me based on the claim(s) made by me in the BEP Action, including, but not limited to, any money, or other valuable consideration, paid in partial or complete settlement of the claim(s) in the BEP Action, or in partial or complete satisfaction of any judgment in the BEP Action, and any money from any post trial collection activities arising from, or related to, any judgment in the BEP Action, to ALGPC up to the total amount of the any and all legal fees and costs due and payable by me to ALGPC for legal fees and costs effective as of the date of the payment of any money, or other valuable consideration paid in partial or complete settlement of the claim(s) in the BEP Action or in partial or complete satisfaction of any judgment in the BEP Action ("BEP Money"). The net amount of any and all BEP Money after payment to ALGPC for legal fees and costs will be payable to George Clinton or his nominee or assignee.


