3 1. Defendants Sasson Jacoby and Shmuel Ben Yaeesh a/k/a Shumell
4 Ben Yaeesh are found liable to plaintiff on all claims raised by plaintiff in the
5 above-referenced action and a judgment in the amount of \$75,001.00 is hereby
6 entered jointly and severally against defendants Sasson Jacoby and Shmuel Ben
7 Yaeesh a/k/a Shumell Ben Yaeesh for willful and malicious trademark, copyright
8 and right of publicity infringement.

12 2. A permanent injunction is hereby entered permanently enjoining

14 and parties acting in concert with either of them from advertising, selling,
