1 In accordance with the Court's *Order Approving Stipulation for Judgment*
2 *Against Hodayoun (Tony) Namvar and Ramin Namvar* (the "Order") and good cause
3 appearing therefor,

4 **IT IS HEREBY ORDERED AND ADJUDGED THAT:**

- 5 1. Judgment is entered in favor of The Namco Liquidating Trust (the "Trust")
6 against Hodayoun (Tony) Namvar in the amount of \$971,684.12 (the
7 "Hodayoun (Tony) Namvar Principal Sum") and in favor of the Trust
8 against Ramin Namvar in the amount of \$390,844.26 (the "Ramin Namvar
9 Principal Sum").
- 10 2. Post-judgment interest shall accrue on the Hodayoun (Tony) Namvar
11 Principal Sum and the Ramin Namvar Principal Sum and be payable to the
12 Trust at the lawful rate under California law as of the date of entry of this
13 Judgment.
- 14 3. This Court retains jurisdiction to hear and determine all matters arising from
15 or related to this Judgment and the Order.
