
1 Defendant's said default under the Stipulation, the Court finding
2 good cause therefore, grants said Application as follows:

3 **IT IS ADJUDGED, ORDERED AND DECREED that:**

- 4 1. Judgment shall be and hereby is entered in favor of Plaintiff
5 ABBATE FAMILY FARMS LIMITED PARTNERSHIP, a California limited
6 partnership and against Defendant CHENCHO PEREZ, an
7 individual, d/b/a CHP Produce in the principal amount of
8 \$107,594.73;
- 9 2. The Court further awards Plaintiff ABBATE FAMILY FARMS LIMITED
10 PARTNERSHIP, a California limited partnership, prejudgment
11 interest from through and including April 30, 2011, on said
12 principal amount in the sum of \$2,730.33, and post judgment
13 interest at the daily rate of \$6.03.
- 14 3. The Court further awards Plaintiff ABBATE FAMILY FARMS LIMITED
15 PARTNERSHIP, a California limited partnership, its attorneys
16 fees in the sum of \$1,500.00.
