Dear Erica.

As to Courthouse News Service's motion for a preliminary injunction, as I stated at the outset of our call, Courthouse News Service had been prepared to grant Mr. Planet a short extension of time to respond to that motion, and had also been willing to agree to a schedule that would have put the hearing on the motion for a preliminary injunction and Mr. Planet's anticipated motion to dismiss on the same date.
