As you know, we are the attorneys for Courthouse News Service in the above-referenced matter. As we previously discussed, Courthouse News has appealed to the Ninth Circuit Court of Appeals (“Court of Appeals”) the decision of the U.S. District Court for the Central District of California (“District Court”) related to the motion for preliminary injunction and motion to dismiss, which was heard in Judge Real’s courtroom on November 28, 2011, and for which you were the designated court reporter. As promised, enclosed please find two copies of the Transcript Designation and Ordering Form that we are required to submit to you in order to officially designate the transcript on appeal per Federal Rule of Appellate Procedure 11 and Ninth Circuit Rule 10-3.1, as well as a check for \$12, which you indicated in our phone call on Wednesday, January 4, 2012, was the correct fee for a copy of the transcript.

As we discussed, and per Federal Rule of Appellate Procedure 11(b), please follow the instructions on each Transcript Designation and Ordering Form so that the transcript is properly filed with the District Court. You will see that on Copy Two of the form, you are instructed to first complete Section B, and then send Copy Two to the Court of Appeals in compliance with Rule 11(b). When your preparation of the transcript is complete, you should complete Section C on Copy Three of the form, and then file Copy Three, together with the completed transcript, with the District Court. The Clerk of the District Court will then transmit the transcript to the Court of Appeals.

Per the Court of Appeals’ Time Schedule Order, a copy of which is also enclosed for your convenience, you have until April 16, 2012, to file the transcript, together with Copy Three of the Transcript Designation and Ordering Form, with the District Court.


