7 Plaintiffs Trustees of the Southern California IBEW-NECA Pension Plan,  
8 Trustees of the Southern California IBEW-NECA Health Trust Fund, Trustees of the  
9 Riverside County Electrical Health & Welfare Trust Fund, Trustees of the Inland  
10 Empire IBEW-NECA Health Trust, Trustees of the Los Angeles County Electrical  
11 Educational and Training Trust Fund, Trustees of the Riverside County Educational  
12 and Training Trust Fund, Trustees of the San Bernardino County Electrical  
13 Educational and Training Trust Fund, Trustees of the Southern California IBEW-  
14 NECA Labor-Management Cooperation Committee, Trustees of the Inland Empire  
15 Labor-Management Cooperation Committee, Trustees of the National Electrical  
16 Benefit Fund, Contract Compliance Fund, National Electrical Industry Fund and Los  
17 Angeles Electrical Workers Credit Union, shall recover from defendant Los Angeles  
18 Signal Construction, Inc., the principal amount of \$335,908.32, plus pre-judgment  
19 interest and post judgment interest thereon at the rate of eight percent (8%) per annum
