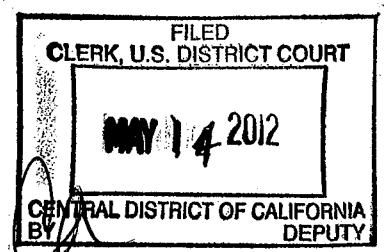

18 Extradition proceedings having been brought in relation to the
 19 fugitive, Gentian Doda ("Mr. Doda"), by Complainant United States
 20 of America pursuant to 18 U.S.C. § 3184 and the Extradition Treaty
 21 in force between the United States and Albania ("the Extradition
 22 Treaty"), and the undersigned judicial officer having considered
 23 the arguments presented by the parties in their papers and at the
 24 extradition hearing held on May 10, 2012, during which no testimony
 25 was taken,

26 IT IS HEREBY FOUND as follows:


27 (1) Probable cause exists to believe that Mr. Doda is the
 28 individual sought by the Albanian government for extradition.

1 (2) Probable cause exists to believe that Mr. Doda is guilty
2 of the offense for which his extradition is sought.

3 (3) Mr. Doda has conceded all remaining elements that the
4 United States must satisfy before extradition can be certified, and
5 the undersigned judicial officer finds those elements to be
6 established.

7 THEREFORE, IT IS HEREBY ORDERED pursuant to 18 U.S.C. § 3184
8 that Mr. Doda is found extraditable and that this matter is
9 certified to the Secretary of State so that a warrant may issue
10 upon the requisition of the proper authorities of the government of
11 Albania for the surrender of Mr. Doda according to the stipulations
12 of the Extradition Treaty, and that Mr. Doda is committed to the
13 custody of the United States Marshal, or his authorized
14 representative, there to remain until such surrender shall be made.
