1 IT IS HEREBY ADJUDGED and DECREED that judgment is entered in  
2 conformity with the arbitration award (the "Award") issued by the Financial  
3 Industry Regulatory Authority ("FINRA") Dispute Resolution arbitration panel in  
4 the binding arbitration between Petitioner UBS Financial Services Inc. ("UBS") and  
5 Respondent David Edward Lamarche ("Lamarche"), entitled *UBS Financial*  
6 *Services Inc., v. David Edward Lamarche*, before the Financial Industry Regulatory  
7 Authority ("FINRA"), Case No. 10-02359, as follows:

- 8 1. Judgment is awarded in favor of UBS and against Lamarche in the  
9 amount of the Award in the sum of \$362,644.24;
- 10 2. Lamarche shall pay UBS post-award, pre-judgment interest on the  
11 above sum at the legal rate of 9% per annum pursuant to New York  
12 Civil Practice Law and Rules Section 5004 (daily interest amount of  
13 \$89.42) from the date of the FINRA Arbitration Award (October 25,  
14 2010) until the date of judgment for a total pre-judgment interest  
15 amount of \$49,449.26; and
- 16 3. Lamarche shall pay UBS post-judgment interest on both the sum set  
17 forth in item 1 above and pre-judgment interest amount set forth in item  
18 2 above at the legal rate pursuant to 28 U.S.C. § 1961 from the date of  
19 the judgment until paid in full.

20 IT IS SO ADJUDGED and DECREED.
