**JUDGMENT**

1 The Court, having considered and approved the stipulation for entry of judgment  
2 submitted by and between defendant Lincoln Pacific Builders, Inc., a California  
3 corporation, and plaintiffs Trustees of the Southern California IBEW-NECA Pension  
4 Plan, Trustees of the Southern California IBEW-NECA Health Trust Fund, Trustees of  
5 the Los Angeles County Electrical Educational and Training Trust Fund, Trustees of the  
6 Riverside County Electrical Health & Welfare Trust Fund, Trustees of the Riverside  
7 County Electrical Education and Training Trust Fund, Trustees of the Inland Empire  
8 Labor-Management Cooperation Committee, Trustees of the National Electrical Benefit  
9 Fund, Trustees of the Southern California IBEW-NECA Labor-Management  
10 Cooperation Committee, Trustees of the National IBEW-NECA Labor-Management  
11 Cooperation Committee, Contract Compliance Fund, National Electrical Industry Fund,  
12 Administrative Maintenance Fund, and the Los Angeles Electrical Worker's Credit  
13 Union (collectively "Trustees"), IT IS HEREBY ORDERED, ADJUDGED AND  
14 DECREED that:

15 The Trustees shall recover from Lincoln Pacific Builders, Inc., a California  
16 corporation, the principal amount of \$418,917.90, plus post-judgment interest at the rate  
17 of 3% per annum, from the date of entry of judgment herein until the date the judgment  
18 is paid in full.
