**JUDGMENT**

1 This action having been commenced on December 13, 2011, and the Court  
2 having approved the stipulation for entry of judgment in favor of plaintiffs Trustees of  
3 the Southern California IBEW-NECA Pension Plan, et al., and against defendant  
4 Southern California Electric, Inc., and for good cause shown,

5 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that:

6 Plaintiffs Trustees of the Southern California IBEW-NECA Pension Plan,  
7 Trustees of the Riverside County Electrical Health and Welfare Trust Fund, Trustees  
8 of the Inland Empire IBEW-NECA Health Trust, Trustees of the Riverside County  
9 Educational and Training Trust Fund, Trustees of the San Bernardino County  
10 Electrical Educational and Training Trust Fund, Trustees of the Inland Empire IBEW-  
11 NECA Labor-Management Cooperation Committee, Trustees of the National IBEW-  
12 NECA Labor-Management Cooperation Committee, and Trustees of the National  
13 Electrical Benefit Fund, National Electrical Industry Fund, and Administrative  
14 Maintenance Fund shall recover from defendant Southern California Electric, Inc., a  
15 California corporation doing business as “So-Cal Electric, Inc.,” the principal amount  
16 of \$4,218.98, together with post-judgment interest thereon at a rate of eight percent  
17 (8%) per annum from the date judgment is entered, until paid in full.
