1 Pursuant to the Settlement Agreement and Stipulation for Judgment by and  
2 between Plaintiff and Counterdefendant SHEILA FERNANDES (“Fernandes”) on  
3 the one hand, and Defendants and Counterclaimants NORTHWESTERN  
4 ENGINEERING COMPANY and HILLS PRODUCTS GROUP, INC. (collectively,  
5 “Northwestern”) on the other hand, IT IS HEREBY ADJUDGED, ORDERED, and  
6 DECREED as follows:

- 7 1. That Northwestern shall have judgment in its favor on Fernandes’

- 9 2. That this Court shall retain continuing jurisdiction over the parties to  
10 enforce the terms and conditions of the Settlement Agreement between
