

BI/CBS-FAMILY NET/COMPLAINT

as follows:

Plaintiff CBS TELEVISION DISTRIBUTION, a division of CBS STUDIOS, INC. ("CBS") is informed and believes, and based thereon alleges, against Defendants COMSTAR MEDIA, LLC, a Delaware limited liability company, COMSTAR NETWORKS, LLC, a Texas limited liability company, FAMILY NET MANAGEMENT, LLC, a Delaware limited liability company, RESOLUTE MEDIA ATLANTA, LLC, a Georgia limited liability company, f/k/a FAMILYNET, LLC, a Delaware limited liability company, and DOES 1 to 100 (collectively, "Defendants")

THE PARTIES

- CBS is a Delaware corporation which conducts business in the County 1. of Los Angeles, State of California.
- 2. CBS is informed and believes, and based thereon alleges, that Defendants COMSTAR MEDIA, LLC and COMSTAR NETWORKS, LLC (collectively, "ComStar") are, or were, limited liability companies formed in Delaware and Georgia which conduct business in the state of California and in this judicial district.
- 3. CBS is informed and believes, and based thereon alleges, that Defendant FAMILY NET MANAGEMENT, LLC ("FNM") is, or was, a Delaware limited liability company which conducts business in the state of California and in this iudicial district.
- CBS is informed and believes, and based thereon alleges, that Defendant RESOLUTE MEDIA ATLANTA, LLC f/k/a FAMILYNET (collectively, "Family") is, or was, a limited liability company originally formed in Delaware and then reformed in Georgia which conducts business in the state of California and in this judicial district.
- The true names and capacities of Defendants sued as Does 1 through 100 5. are unknown to CBS at this time, who therefore sues these Defendants by such

fictitious names. CBS will seek leave to amend this Complaint to insert the true names and capacities of the fictitiously named Defendants when they are ascertained. CBS is informed and believes, and based thereon alleges, that each of the Defendants sued as Does 1 through 100 are television stations or other businesses that have infringed its copyright in the Series (defined below) or are obligated to pay the license fee under the License Agreement (defined below) and, therefore, is in some manner responsible or liable for the acts, occurrences and damages alleged in this Complaint.

6. CBS is informed and believes, and based thereon alleges, that at all times relevant to this Complaint the above-named Defendants, including the Doe Defendants, and each of them, either breached the License Agreement or were copyright infringers, or the agents, employees, partners, successors-in-interest, predecessors-in-interest, co-venturers or co-conspirators of the remaining co-Defendants and, in doing the acts alleged herein, each was acting within the course and scope of such agency, service, employment, partnership, interest, venture or conspiracy with the authorization, ratification, approval and/or agreement of their principals or the remaining co-Defendants.

JURISDICTION AND VENUE

- 7. This is an action for copyright infringement. CBS' claim for copyright infringement arises under the copyright laws of the United States, 17 U.S.C. §§101 et seq. This court has original jurisdiction over this action pursuant to 28 U.S.C. §§1331 and 1338(a). In addition, there is complete diversity between Plaintiffs and Defendants and this Court has diversity jurisdiction over this action as well.
- 8. Venue is proper in this district pursuant to 28 U.S.C. §1391(b) because a substantial part of the events giving rise to the claims arose and occurred within this judicial district and all of the Defendants do business within this judicial district in general and in connection with the particular copyright infringement and contract at

issue in particular. The Defendants have entered into license agreements for television programming within this judicial district or have engaged in copyright infringement causing damages within this judicial district.

FIRST CLAIM FOR RELIEF

(For Breach of Contract Against All Defendants)

- 9. CBS incorporates by reference paragraphs 1 through 9 above as though fully set forth herein.
- 10. CBS and Family entered into a Basic Cable License Agreement, dated as of December 1, 2008. CBS and Family entered into an Amendment to the Basic Cable License Agreement on December 19, 2008. The Basic Cable License Agreement as amended is referred to in this Complaint as the "License Agreement".
- 11. In accordance with the terms and conditions of the License Agreement, CBS licensed to Family the right to exhibit some of CBS's most famous television series: "Happy Days," "My Three Sons", "Family Ties" and "Early Edition" (collectively, the "Series") via the basic cable program service known as FamilyNet (the Network") which included various broadcast, cable and telephone company channels owned by Family.
- 12. Pursuant to the terms of the License Agreement, Family was obligated to pay to CBS the agreed upon license fees in the amount set forth in the License Agreement for the right to exhibit the Series, with an initial down payment payable on or before December 31, 2008 and thirty-two monthly installments thereafter.
- 13. CBS alleges on information and belief that in or about December 2009, ComStar acquired Family, through FNM, a wholly owned subsidiary of ComStar which was created solely for that purpose.
- 14. ComStar and FNM continued to exhibit the Series on the Network acquired by them from Family. ComStar, through FNM, paid some of the license fee payments for the Series including a cashier's check dated June 18, 2010 in an amount

in excess of \$100,000 (the "June 18, 2010 Check"). CBS is informed and believes, and based thereon alleges, that ComStar, FNM and the other Defendants assumed the obligations of Family due and owing to CBS to pay the license fees required by the License Agreement. However, after the payment of the June 18, 2010 Check, ComStar and FNM failed to make any of the remaining installment payments to CBS. In addition, none of the remaining installment payments have been made to CBS by Family.

- 15. CBS performed all of the covenants and conditions of the License Agreement, except for those provisions which are excused or rendered unnecessary by virtue of Defendants' breach.
- 16. Defendants have breached the License Agreement by failing to make the payments due to CBS pursuant to the terms of the License Agreement.
- 17. As a proximate result of Defendant's breach of contract, CBS has suffered damages in an amount according to proof at the time of trial, but at least in the amount of \$1,546,880.08 together with interest thereon at the maximum allowable legal rate from the date of the breach.

SECOND CLAIM FOR RELIEF

(For Copyright Infringement Against Defendants ComStar, FNM and Does 1 to 100)

- 18. CBS incorporates by reference paragraphs 1 through 14 above as though fully set forth herein.
- 19. CBS is the owner and holder of the exclusive copyright in and to the Series and has the exclusive right, under Section 106 of the Copyright Act, to license to third parties the right to exhibit the Series on cable television. Attached hereto as Exhibit "A" are true and correct copies of exemplars of a Certificate of Registration for a particular episode of each of the Series. The Certificate of Registration for the exemplar episode of "My Three Sons" and "Early Edition" are in the name of CBS.

The Certificate of Registration for the exemplar episode of "Happy Days" and "Family Ties" are in the name of Paramount, however, on December 21, 2005, Paramount assigned the copyrights in and to the episodes of "Happy Days" and "Family Ties" to CBS.

- 20. Despite failing to make the payments required by the License Agreement, Defendants have continued to exhibit and exploit the Series via the Network which included various broadcast, cable and telephone company channels owned by Defendants.
- 21. ComStar and FNM have informed CBS that they have no obligation to make the payments due under the License Agreement because, they claim, when they acquired the assets of Family, they did not acquire the corresponding liabilities. However, CBS is informed and believes, and based thereon alleges, that this assertion is contrary to the facts and the law and, moreover, that ComStar, FNN and the other Defendants have no right to exhibit or exploit the Series unless and until they pay the licensee fees set forth in the License Agreement. Without making such payments, ComStar, FNM and the other Defendants have exceeded the scope of any license. As a result, they are copyright infringers.
- 22. Without the assumption of Family's obligation to make the installment payments under the License Agreement, neither ComStar, FNM nor any of the other Defendants could have acquired the license to exhibit or exploit the Series because Family could not assign its license to ComStar, FNM or any other Defendant without the approval of CBS. See *Gardner vs. Nike*, 279 F.3d 774, 781 (9th Cir. 2002).
- 23. CBS did not approve the assignment of Family's licensed rights to ComStar, FNM or any other Defendant under the License Agreement, nor would it, without the complete assumption of all of the obligations to CBS including the payment of all amounts due to CBS under the License Agreement.

- 24. As, such, the repeated exhibition and exploitation of the Series by ComStar, FNM and the other Defendants on their cable stations is a violation of 17 U.S.C. § 106 as these rights are exclusively reserved to the copyright holder.
- 25. Despite CBS's repeated request for payment and instruction to ComStar and FNM to stop all exhibition and exploitation of the Series, ComStar, FNM and the other Defendants refused to do so in bad faith and in willful violation of the rights of CBS and continued to exhibit the Series.
- 26. Based on the foregoing, CBS is entitled to an award of actual damages plus a disgorgement of the profits attributable to the unauthorized airing of the Series by ComStar, FNM or any other Defendant, or statutory damages, including enhanced statutory damages based on ComStar and FNM's willful conduct, for each copyright infringed, plus punitive damages. CBS is also entitled to recovery of its attorneys' fees pursuant to 17 U.S.C. § 505.

WHEREFORE, CBS prays for relief against Defendants, and each of them, as follows:

FIRST CLAIM FOR RELIEF

- 1. for damages according to proof at the time of trial, but at least in the amount of \$1,546,880.08, plus interest thereon at the maximum allowable legal rate;
 - 2. for costs of suit herein;
 - 3. for attorneys' fees pursuant to law or contract; and
 - 4. for such other and further relief as this Court deems just and proper.

SECOND CLAIM FOR RELIEF

1. for actual damages and disgorgement of profits, on a Defendant-by-Defendant basis, or statutory damages and/or enhanced statutory damages for the


