In accordance with this Court's ORDER RE PLAINTIFFS' MOTION FOR SUMMARY JUDGMENT and ORDER RE PLAINTIFFS' MOTION FOR DEFAULT JUDGMENT, filed on August 22, 2013, which granted Plaintiffs' Motion for Summary Judgment against Defendant Duc Hien Pham and Plaintiffs' Motion for Default Judgment Against Sunshine Shipping, Inc., the Court HEREBY GRANTS JUDGMENT in favor of Plaintiff Nippon Yusen Kaisha, and against Defendants Duc Hien Pham and Sunshine Shipping, Inc., in the amount of \$151,401.86, plus prejudgment interest of \$991.89, plus attorneys' fees of \$29,050.00, and collection costs of \$7,624.40, for a total judgment of \$189,068.15. Duc Hien Pham and Sunshine Shipping, Inc. are jointly and severally liable for the total judgment of \$189,068.15.

The Court also awards Nippon Yusen Kaisha interest on the judgment until paid under 28 U.S.C. §1961.
