1 The Court, pursuant to the Stipulation for Entry of Judgment  
2 (“Stipulation”), between Plaintiff Celine Tran (“Plaintiff”) on the one hand and  
3 Defendant Shad Gregory Moss (“Defendant”) on the other and attached hereto  
4 as Exhibit A, hereby orders that the Stipulation executed between Plaintiff and  
5 Defendant be deemed the actual judgment entered by the Court in the above-  
6 captioned matter:

7 1. Pursuant to the Stipulation, Plaintiff is entitled to recover from  
8 Defendant:

- 9 a. The sum of \$51,666.67 on Plaintiff’s Complaint, subject to the  
10 terms of the Stipulation;  
11 b. The sum of \$13,918.00 in reasonable attorney fees and costs  
12 incurred in connection with the preparation and filing of  
13 Plaintiff’s Request for Entry of Judgment; and  
14 c. Any future reasonable attorney fees and costs that may be further  
15 incurred in connection with the enforcement of the Court’s  
16 Judgment.

17 2. No Appeals and Continuing Jurisdiction. No appeals shall be taken  
18 from this Judgment, and all parties waive all rights to appeal. This  
19 Court expressly retains jurisdiction over this matter to enforce any  
20 violation of the terms of this Judgment.

21 All pending dates are vacated. The Clerk shall close this action.
