The Motion for Summary Judgment, or Alternatively, Summary Adjudication of Issues (causes of action and punitive damage claim) by defendant Prysmian Power & Cable Systems USA, a.k.a. Prysmian Cables & Systems USA, LLC (“Prysmian”) came regularly for hearing on January 27, 2014, in Courtroom 8 of the District Court, the Hon. Manuel L. Real, Judge presiding.

1 Plaintiff Paul Olds filed no opposition. After considering the admissible evidence,
2 arguments and separate statement provided by Prysmian, the Court hereby finds that there is no
3 genuine issue as to any material fact and that, therefore, defendant Prysmian Power & Cable
4 Systems USA, a.k.a. Prysmian Cables & Systems USA, LLC is entitled to judgment on the
5 merits, as a matter of law, with respect to each cause of action pleaded against it, as follows:

6 1. There is no genuine issue as to any material fact regarding Plaintiff Paul Olds'
7 first cause of action, for "Negligence," as pleaded against Prysmian;

8 2. There is no genuine issue as to any material fact regarding Plaintiff Paul Olds'
9 second cause of action, for "Strict Product Liability," as pleaded against Prysmian; and

10 3. There is no genuine issue as to any material fact regarding Plaintiff Paul Olds'
11 third cause of action, for "Breach of Warranty," as pleaded against Prysmian.

12 Now, therefore,

13 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Plaintiff Paul Olds
14 shall take nothing pursuant to his Complaint in this Action, and that Judgment shall be, and
15 hereby is, entered in favor of defendant Prysmian Power & Cable Systems USA, a.k.a.
16 Prysmian Cables & Systems USA, LLC.

17 Further, defendant Prysmian Power & Cable Systems USA, a.k.a. Prysmian Cables &
18 Systems USA, LLC is the prevailing party, and therefore shall recover its costs of suit as
19 against Plaintiff Paul Olds in a sum to be determined pursuant to L.R. 54-2 and *F.R.Civ.P.*
20 54(d).
