1 THIS MATTER is before the Court at the stipulated requested of Plaintiff
2 Endurance American Specialty Insurance Company (“Endurance”) and Defendant
3 Hamilton Brewart Insurance Agency LLC (“HBIA”).

4 This Court previously entered the following:

5 1. On January 29, 2013, a Default by Clerk was entered as to Derek
6 Brewart, as Trustee of the Hamilton Brewart Trust (Docket No. 59).

7 2. On April 18, 2013, this Court granted Endurance’s Motion for Summary
8 Judgment against Defendants Derek Brewart, individually, and as Trustee of the
9 Hamilton Brewart Trust (Docket No. 106).

10 In light of the Court’s rulings and a settlement entered into by and between
11 Endurance and HBIA, pursuant to Federal Rule Civil Procedure 41(a)(1)(A)(ii), the
12 following matters have been dismissed with prejudice by Stipulation:

13 3. HBIA’s Counter-claim as against Endurance (Docket No. 57).

14 THEREFORE, IT IS HEREBY ORDERED and ADJUDGED as follows:

15 1. Judgment is entered in favor of Endurance against Defendants Derek
16 Brewart, individually and as Trustee of the Hamilton Brewart Trust, on
17 the grounds set forth in the Court’s April 18, 2013 Order (Docket No.
18 106), which Order is incorporated herein by reference as though fully set
19 forth;

20 2. The Professional Liability Insurance Policy, Number PPL 10002126201
21 that Endurance issued to Hamilton Brewart Insurance Agency LLC for
22 the Policy Period of July 1, 2011 to July 1, 2012 is rescinded and is
23 rendered void *ab initio*.


24 3. The Professional Liability Insurance Policy, Number PPL 10002126202
25 that Endurance issued to Hamilton Brewart Insurance Agency LLC for
26 the Policy Period of July 1, 2012 to July 1, 2013 is rescinded and is
27 rendered void *ab initio*.
