2 **NOTICE IS HEREBY GIVEN** that in accordance with Local Rule 79-5.1,

4 apply for an order permitting them to file under seal the following:

7 2) Exhibit 1 to the Declaration of Michael Jones in Support of Rocket

10 This application is made pursuant to Local Rule 79-5 et seq. and the
11 Stipulated Protective Order, entered on September 24, 2013 (ECF No. 39). Based
12 on the below reasons, the Opposition and the Exhibit, the pleadings, papers and

14 as presented at the hearing.

15 **REASONS SUPPORTING RELIEF REQUESTED**

16 Good cause exists to seal the Opposition and the Exhibit. These documents
17 are subject to the Court’s protective order and the sealing of these documents is
18 necessary in order to protect information that Rocket Lawyer has designated as
19 “confidential” and “attorneys’ eyes only,” including without limitation, confidential

26 order the Opposition and the Exhibit be filed under seal.


