At the initial Rule 26 meet and confer in March 2013, the parties discussed an early settlement conference or mediation to determine whether settlement without further litigation was possible. The parties attended formal mediation before Judge William J. Cahill (Ret.) on May 28, 2013. The parties did not reach a settlement that day. The parties continued to mediate and discuss settlement in good faith, with the assistance of Judge Cahill, until August 22, 2013.
