Plaintiff and counterclaim defendant LegalZoom.com, Inc. (“LegalZoom”) and defendant and counterclaimant Rocket Lawyer Incorporated (“RLI”) hereby stipulate as follows:

1. On December 19, 2014, the Court issued a minute order setting a status conference for January 7, 2015, at 10:30 a.m., and required all lead trial counsel to be present at the status conference.

2. Lead trial counsel for plaintiff LegalZoom, Fred Heather, represents that he has a trial which is scheduled to proceed on January 7, 2015, in Los Angeles Superior Court, Case No. BF045218, and which may prevent his participation at the status conference. Mr. Heather’s partner, Aaron Allan, who will be second chair at any trial in the present action, is available to participate in the status conference.
