1 Pursuant to Federal Rule of Civil Procedure 41(a)(2), LegalZoom.com, Inc.
2 (“LegalZoom”) and Rocket Lawyer Incorporated (“Rocket Lawyer”) (together, the
3 “Parties”), stipulate and agree as follows:

4 1. LegalZoom and Rocket Lawyer have executed a Confidential
5 Settlement and General Release effective June 25, 2015 (the “Settlement
6 Agreement”).

7 2. Pursuant to the Settlement Agreement, the Parties agree to dismiss the
8 above-captioned action in its entirety, including all claims and counterclaims.

9 3. LegalZoom hereby **DISMISSES WITH PREJUDICE** the First
10 Amended Complaint, ECF NO. 14, and all claims therein.

11 4. Rocket Lawyer hereby **DISMISSES WITH PREJUDICE** the
12 Amended Counterclaims, ECF NO. 17, and all counterclaims therein.

13 5. The Parties shall each bear their own costs and attorneys’ fees.

14 6. The United States District Court for the Central District of California
15 shall retain jurisdiction solely for the purpose of enforcing the Settlement
16 Agreement.
