1           WHEREAS, LegalZoom.com, Inc. (“LegalZoom”) and Rocket Lawyer  
2 Incorporated (“Rocket Lawyer”) (together, the “Parties”) have executed a  
3 Confidential Settlement and General Release effective June 25, 2015 (the  
4 “Settlement Agreement”); and

5           WHEREAS, pursuant to the Settlement Agreement, the Parties agreed to  
6 dismiss the above-captioned action in its entirety, including all claims and  
7 counterclaims.

8           THEREFORE, GOOD CAUSE APPEARING, IT IS HEREBY ORDERED:

- 9           1.     LegalZoom’s First Amended Complaint, ECF NO. 14, is dismissed in  
10 its entirety with prejudice.
- 11           2.     Rocket Lawyer’s Amended Counterclaims, ECF NO. 17, are dismissed  
12 in their entirety with prejudice.
- 13           3.     The Parties shall each bear their own costs and attorneys’ fees.
- 14           4.     This Court shall retain jurisdiction solely for the purpose of enforcing  
15 the Settlement Agreement.
