**DECLARATION OF TRAVIS GIGGY**

I, TRAVIS GIGGY, declare and state as follows:

1. I submit this declaration in support of the Motion for Partial Summary Judgment brought by Plaintiff LegalZoom.com, Inc. (“LegalZoom”). I am over the age of 18 years. Unless otherwise indicated, I have personal knowledge of the facts set forth herein, and if called upon to testify thereto, I could and would competently do so under oath.

2. I was an employee of LegalZoom from May 2003 to June 2006 and from January 2007 to April 2008 and then a consultant to LegalZoom from July 2006 to December 2006 and May 2008 to June 2012.

3. I was the owner, operator and moderator of Legalspring.com from 2004 until March 1, 2013 when Legalspring.com was sold to Inenvi, Inc.

4. During the time of my ownership, Legalspring.com was an affiliate referral site for various online legal service providers such as LegalZoom, IncorporateFast, The Company Corporation, MyCorporation.com and BizFilings.

5. Between 2004 and March 1, 2013, I selected and published on the Legalspring.com website opinions as well as third party customer reviews about various online legal service providers, including LegalZoom.

6. Attached to the Appendix as Exhibit A is a true and correct copy of various web pages on the Legalspring.com website as of December 11, 2012. These web pages display opinions and links to third party customer reviews about various legal service providers, including LegalZoom.

7. While many of the third party customer reviews about LegalZoom on the Legalspring.com website are positive, several of them are not.

8. Like other affiliate referral sites, Legalspring.com received commissions and/or other compensation from its affiliates, including from LegalZoom.
