1 This action having been commenced on March 29, 2013, and an initial  
2 judgment having been entered herein on July 26, 2013, and the Court having approved  
3 the stipulation for entry of amended judgment in favor of plaintiffs, Trustees of the  
4 Southern California IBEW-NECA Pension Plan, et al., and against defendant,  
5 Certified Crane Services, Inc., a California corporation, and for good cause shown,

6 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that:

7 (1) Plaintiffs TRUSTEES OF THE SOUTHERN CALIFORNIA IBEW-  
8 NECA PENSION PLAN, TRUSTEES OF THE SOUTHERN CALIFORNIA IBEW-  
9 NECA HEALTH TRUST FUND, TRUSTEES OF THE LOS ANGELES COUNTY  
10 ELECTRICAL EDUCATIONAL AND TRAINING TRUST FUND, TRUSTEES OF  
11 THE SOUTHERN CALIFORNIA IBEW-NECA LABOR-MANAGEMENT  
12 COOPERATION COMMITTEE, TRUSTEES OF THE NATIONAL IBEW-NECA  
13 LABOR-MANAGEMENT COOPERATION COMMITTEE, TRUSTEES OF THE  
14 NATIONAL ELECTRICAL BENEFIT FUND, and the LOS ANGELES  
15 ELECTRICAL WORKERS CREDIT UNION shall recover from defendant  
16 CERTIFIED CRANE SERVICES, INC. a California corporation, the principal  
17 amount of \$24,649.69, plus pre-judgment and post-judgment interest thereon at the  
18 rate of eight percent (8%) per annum accruing from November 1, 2013, until the  
19 judgment is paid in full.
