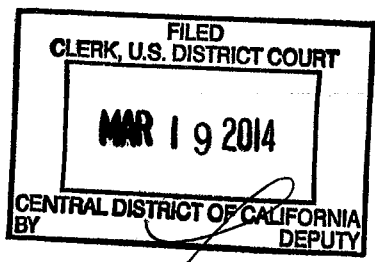

 24 be dismissed, in its entirety, with prejudice. Each party will bear its own costs and




