 CONSENT DECREE AND  
 PERMANENT INJUNCTION

24 The Court, having read and considered the Joint Stipulation for Entry of  
 25 Consent Decree and Permanent Injunction that has been executed by Plaintiff Warner  
 26 Bros. Home Entertainment Inc. (“Plaintiff”) and Defendant David Skinner, an  
 27 individual and d/b/a Amazon.com Seller david93230 (“Defendant”), in this action, and  
 28 good cause appearing therefore, hereby:

1           ORDERS that based on the Parties’ stipulation and only as to Defendant, his  
2 successors, heirs, and assignees, this Injunction shall be and is hereby entered in the  
3 within action as follows:

4           1)     This Court has jurisdiction over the parties to this action and over the subject  
5 matter hereof pursuant to 17 U.S.C. § 101 *et seq.*, and 28 U.S.C. §§ 1331 and 1338.  
6 Service of process was properly made against Defendant.

7           2)     Plaintiff owns or controls the copyright or pertinent exclusive right to distribute  
8 or license the distribution of home video and digital products, including video home  
9 cassettes (VHS) as well as optical discs, including, but not limited to, digital versatile  
10 discs (DVDs) and Blu-ray discs (collectively “Media Products”) incorporating the  
11 motion picture or television titles subject to the copyright registrations listed in Exhibit  
12 “A” attached hereto and incorporated herein by this reference (collectively referred to  
13 herein as “Plaintiff’s Works”).

14           3)     Plaintiff has alleged that Defendant has made unauthorized uses of Plaintiff’s  
15 Works or substantially similar likenesses or colorable imitations thereof.

16           4)     Defendant and his agents, servants, employees, representatives, successor and  
17 assigns, and all persons, firms, corporations or other entities in active concert or  
18 participation with her who receive actual notice of the Injunction are hereby restrained  
19 and permanently enjoined from infringing – directly, contributorily or vicariously – or  
20 enabling, facilitating, permitting, assisting, soliciting, encouraging, inducing,  
21 authorizing, aiding or abetting, materially contributing to, or persuading anyone to  
22 infringe in any manner Plaintiff’s Works, including, but not limited to, the following:

- 23           a)     Copying, reproducing, downloading, distributing, uploading, linking to,  
24                 transmitting, or publicly performing, or using trademarks, trade names or  
25                 logos in connection with unauthorized Media Products containing any of  
26                 Plaintiff’s Works;

- b) Enabling, facilitating, permitting, assisting, soliciting, encouraging, abetting, or inducing any person or entity to copy, reproduce, download, distribute, upload, link to, transmit, or publicly perform any of Plaintiff's Works; or
- c) Profiting from the unauthorized copying, reproduction, downloading, distribution, uploading, linking to, transmission, or public performance of any of Plaintiff's Works while declining to exercise a right to stop or limit such unauthorized copying, reproduction, downloading, distribution, uploading, linking to, transmission, or public performance of any of Plaintiff's Works.

- 5) Each side shall bear its own fees and costs of suit.
- 6) Except as provided herein, all claims alleged in the Complaint are dismissed with prejudice.
- 7) This Injunction shall be deemed to have been served upon Defendant at the time of its execution by the Court.
- 8) The Court finds there is no just reason for delay in entering this Injunction and, pursuant to Rule 54(a) of the Federal Rules of Civil Procedure, the Court directs immediate entry of this Injunction against Defendant.
- 9) The Court shall retain jurisdiction of this action to entertain such further proceedings and to enter such further orders as may be necessary or appropriate to implement and enforce the provisions of this Injunction.
- 10) The above-captioned action, shall, upon filing by Plaintiff of the Settlement Agreement, Stipulation for Entry of Judgment and Judgment Pursuant to Stipulation, and requesting entry of judgment against Defendant, be reopened should Defendant default under the terms of the Settlement Agreement.
- 11) This Court shall retain jurisdiction over Defendant for the purpose of making further orders necessary or proper for the construction or modification of this consent

1 decree and judgment; the enforcement hereof; the punishment of any violations  
2 hereof; and for the possible entry of a further Judgment Pursuant to Stipulation in this  
3 action.
