Fed.R.Civ.Proc. 4(m). Generally, defendants must answer the complaint within 20 days after service (60 days if the defendant is the United States). Fed.R.Civ.Proc. 12(a)(1).

Accordingly, the court, on its own motion, orders plaintiff(s) to show cause in in writing on or before <u>August 12, 2013</u> why this action should not be dismissed for lack of prosecution. The Order To Show Cause will stand submitted upon the filing of plaintiff's response.
