1 I, JEREMY BLIETZ, hereby declare:

2 1. I am currently the Vice President of Administration at Warner/Chappell
3 Music, Inc. ("Warner/Chappell"). I have been asked to provide this Declaration in
4 support of Warner/Chappell's Opposition to Plaintiff's Motion to Exclude Evidence.
5 I have personal knowledge of the facts stated herein and if called upon as a witness
6 to testify as to them, I could and would competently do so.

7 2. In the fall of 2013, Lisa Minnerly, a Warner/Chappell employee who
8 reports to me, and I asked the Copyright Office to provide Warner/Chappell with
9 copies of the "copyright registrations" for E51990 and E51988.

10 3. The Copyright Office responded to our requests in December 2013, by
11 providing Warner/Chappell with a document containing a cover page stating "Copy
12 of Registration E51990" and a document containing a cover page stating "Copy of
13 Registration E51988." True and correct copies of these documents were submitted
14 as Exhibits 101 and 103, respectively, of the amended joint evidentiary appendix
15 ("Appendix") that the parties in this litigation filed in support of their cross-motions
16 for summary judgment. The Copyright Office sent Warner/Chappell these
17 documents with a cover letter, dated December 9, 2013, that identified the
18 documents as "Copies of Registrations." A true and correct copy of this letter was
19 submitted as Exhibit 125 of the Appendix.

20 I declare under penalty of perjury under the laws of the United States that the
