- On or about October 29, 2009, Majar paid defendant Warner/Chappell \$5,000 for a Synchronization License to use Happy Birthday to You.
- I did not learn that there was a dispute with respect to whether or not 3. defendant Warner/Chappell owned a copyright of Happy Birthday to You until this lawsuit was filed in June 2013. Prior to June 2013, I never heard about nor did I read the article written by Professor Brauneis that argued Warner/Chappell did not own a copyright to Happy Birthday to You.
- Prior to the filing of this lawsuit, I had no reason to believe nor did I suspect that Warner/Chappell did not own a copyright to Happy Birthday to You. To the contrary, it was commonly known in the entertainment industry that Warner/Chappell claimed an exclusive copyright to Happy Birthday to You and it had been collecting royalties for use of the song for decades.
