7 aware of attorneys' fees, which was filed on April 27, 2016.


8 3. For 20 years, I have provided entertainment legal services in the areas of  
9 film, television, music, new media, publishing, stage, copyright, and trademark law.  
10 My practice is located on Wilshire Boulevard in Los Angeles, and many of my  
11 clients are located in Los Angeles within this judicial district. Sometimes these  
12 clients require my services at remote locations outside of the state.

13 4. I represent and provide counsel to individuals and companies. My  
14 current clients include production companies, producers, directors, talent, writers,  
15 recording artists, record labels, publishers, management companies, content creators,  
16 and others.

17 5. I regularly provide services to my clients on an hourly fee basis. It is  
18 my custom and practice to charge my clients for my travel time at 100% of my

21 clients pay for my travel time at the billed hourly rates.
