12 **BRIEF FACTUAL STATEMENT**


13 As with this instant action, the plaintiff in *Siegel v. Warner/Chappell Music*
14 *Inc.* also seeks the following: 1) to declare invalid the copyright that defendant
15 Warner/Chappell Music, Inc. ("defendant") claims to own to the world's most
16 popular song, *Happy Birthday to You* (the "Song"); 2) to declare that *Happy*
17 *Birthday to You* is dedicated to public use and in the public domain; and 3) to return
18 millions of dollars of unlawful licensing fees collected by defendant pursuant to its
19 wrongful assertion of copyright ownership of the Song.

20 WHEREFORE, Plaintiff Mayra respectfully requests:

- 21 1. That this action be assigned to the Honorable George H. King, the
22 Judge assigned to the low-numbered action, CV 13-4418 GHK (MRWx); and
23 2. That all subsequent related actions be assigned to the Honorable
24 George H. King.
