The petition indicates that Petitioner is confined at the California State Prison, Los Angeles in Lancaster which lies within the venue of the Western Division of the Central District of California. See 28 U.S.C. 84(c).

Accordingly, the above-titled action is hereby TRANSFERRED to the United States District Court for the Western Division of the Central District of California.
