1 On June 10, 2014, judgment was entered in this matter in favor of Plaintiffs /
2 Judgment Creditors, Trustees of the Southern California Pipe Trades Health and
3 Welfare Trust Fund, Trustees of the Southern California Pipe Trades Pensioners and
4 Surviving Spouses Health Fund, Trustees of the Southern California Pipe Trades
5 Retirement Trust Fund, Trustees of the Southern California Pipe Trades Defined
6 Contribution Trust Fund, Trustees of the Southern California Pipe Trades Vacation and
7 Holiday Trust Fund, Trustees of the Southern California Pipe Trades Christmas Bonus
8 Fund, Trustees of the Apprentice and Journeyman Training Trust Fund, Trustees of the
9 Plumbers and Pipefitters National Pension Fund, and Trustees of the International
10 Training Fund (collectively, the “Trustees”) and against Defendants / Judgment
11 Debtors A.G.F. Construction, Inc. (“AGF”) and Richard Ray Morrison (“Richard
12 Morrison”), jointly and severally, for “\$175,819.26, plus-judgment interest thereon at
13 the statutory rate, until the judgment is paid in full.”

14 On July 28, 2014, the Trustees recorded with the Ventura County Clerk and
15 Recorder an Abstract of Judgment, which is identified as Instrument Number
16 20140728-00093481-0 1/3.

17 NOW, upon application for renewal of judgment by the Trustees, and upon
18 declaration showing that the judgment has not been vacated, reversed, or satisfied, the
19 judgment against AGF and Richard Morrison is renewed in the amount of \$121,798.34
20 as follows:
