7 of the parties, **NOW FINDS AND RULES AS FOLLOWS:**

8 **GOOD CAUSE APPEARING THEREFOR:**

9 The Stipulation to Judgment is hereby approved.

- 10 1. QINGDAO YIJIA NATIVE IMP. & EXP. CO. LTD is to recover the sum of
11 \$16,410,000 from YIHE CORPORATION for QINGDAO YIJIA

13 2. The Parties are ordered to abide by the terms of the Settlement Agreement
14 executed concurrently herewith and to fulfill the executory provisions
15 contained therein;
16 3. This Court shall retain continuing jurisdiction over the enforcement,
17 construction and interpretation of this Consent to Judgment and Order.

18 Subject to the terms of this Judgment and in consideration of the Stipulation for
19 Dismissal [17], the clerk shall close this entire action. Each party shall bear its own
20 attorney fees and costs.
