JUDGMENT

1 On February 21, 2017, the Court entered an order granting the motion for
2 summary judgment filed by Defendant Alta-Dena Certified Dairy, LLC
3 (“Defendant”), concluding that there is no genuine dispute as to any material fact
4 and Defendant is entitled to judgment as a matter of law on all of Plaintiff’s
5 asserted claims. *See* Dkt. No. 123.

6 Pursuant to the Court’s Order Granting Defendant’s Motion for Summary
7 Judgment and Federal Rule of Civil Procedure 58(a), IT IS HEREBY ADJUDGED
8 that Plaintiff’s claims are all dismissed with prejudice, that Plaintiff shall take
9 nothing, that JUDGMENT IS ENTERED IN FAVOR OF DEFENDANT on all of
10 Plaintiff’s claims, and that Defendant shall recover its costs incurred herein.
11 Defendant may file a bill of costs no later than fourteen days after entry of this
12 judgment.
