

1 Pursuant to the Court’s Order dated December 30, 2015 granting the Motion
2 for Summary Judgment submitted by defendants Twenty-First Century Fox, Inc.,
3 Fox Entertainment Group, Inc., Twentieth Century Fox Film Corporation, Twentieth
4 Television, Inc., Twentieth Century Fox Home Entertainment, LLC, Twentieth
5 Century Fox Int’l Television, Inc., Fox Networks Group, Inc., Fox Broadcasting
6 Company, Fox Television Stations, Inc., Fox International Channels (US), Inc.,
7 erroneously sued as Fox International Channels, Inc., Elizabeth Meriwether,
8 Elizabeth Meriwether Pictures, Jacob Kasdan, Brett Baer, David Finkel, American
9 Nitwits, Peter Chernin, The Chernin Group, LLC, and Chernin Entertainment, LLC
10 (collectively the “Fox Defendants”), along with William Morris Endeavor
11 Entertainment, LLC (“WME”) (the Fox Defendants and WME are collectively
12 referred to as “Defendants”), the Court’s February 26, 2016 order on Defendants’
13 Bills of Costs, and the Court’s March 9, 2016 Order Granting Defendants’ Motions
14 for Attorney’s Fees,

15 IT IS HEREBY ORDERED AND ADJUDGED AND DECREED that
16 judgment is entered in favor of Defendants in the above-captioned action. This
17 action is dismissed on the merits. Plaintiffs Stephanie Counts (a/k/a Stephanie
18 Counts-Skinner) and Shari Gold (a/k/a Sharon Gold) shall take nothing against
19 Defendants. The Fox Defendants shall recover costs of \$7,967.52 and fees of
20 \$548,772.77 from Plaintiffs. WME shall recover costs of \$1,716.08 and fees of
21 \$220,063.75 from Plaintiffs.
