 AND PERMANENT INJUNCTION

32 The Court, having read and considered the Joint Stipulation for Entry of
 33 Consent Decree and Permanent Injunction that has been executed by Plaintiff
 34 DeVry/Becker Educational Development Corporation (“Plaintiff”) and Defendant
 35 Christian Hamilton (“Defendant”), in this action, and good cause appearing therefore,

1 hereby:

2 ORDERS that based on the Parties' stipulation and only as to Defendant, his
3 successors, heirs, and assignees, this Injunction shall be and is hereby entered in the
4 within action as follows:

5 1) This Court has jurisdiction over the parties to this action and over the subject
6 matter hereof pursuant to 17 U.S.C. § 101 *et seq.*, and 28 U.S.C. §§ 1331 and 1338.
7 Service of process was properly made against Defendant.

8 2) Plaintiff is the owner of all rights in and to the copyright and trademark
9 registrations listed in Exhibits A and B attached hereto and incorporated herein by this
10 reference (collectively referred to herein as "Plaintiff's Properties").

11 3) Plaintiff has alleged that Defendant has made unauthorized uses of Plaintiff's
12 Properties or substantially similar likenesses or colorable imitations thereof.

13 4) Defendant and his agents, servants, employees and all persons in active concert
14 and participation with him who receive actual notice of the Injunction are hereby
15 restrained and enjoined from:

16 a) Infringing Plaintiff's Properties, either directly or contributorily, in any
17 manner, including generally, but not limited to manufacturing, importing,
18 distributing, advertising, selling and/or offering for sale any unauthorized
19 product which features any of Plaintiff's Properties ("Unauthorized Products"),
20 and, specifically from:

21 i) Importing, manufacturing, distributing, advertising, selling and/or
22 offering for sale the Unauthorized Products or any other unauthorized
23 products which picture, reproduce, copy or use the likenesses of or bear a
24 substantial similarity to any of Plaintiff's Properties;

25 ii) Importing, manufacturing, distributing, advertising, selling and/or
26 offering for sale in connection thereto any unauthorized promotional
27 materials, labels, packaging or containers which picture, reproduce, copy
28

1 or use the likenesses of or bear a confusing similarity to any of Plaintiff's
2 Properties;

3 iii) Engaging in any conduct that tends falsely to represent that, or is
4 likely to confuse, mislead or deceive purchasers, Defendant's customers
5 and/or members of the public to believe, the actions of Defendant, the
6 products sold by Defendant, or Defendant himself is connected with
7 Plaintiff, is sponsored, approved or licensed by Plaintiff, or is affiliated
8 with Plaintiff;

9 iv) Affixing, applying, annexing or using in connection with the
10 importation, manufacture, distribution, advertising, sale and/or offer for
11 sale or other use of any goods or services, a false description or
12 representation, including words or other symbols, tending to falsely
13 describe or represent such goods as being those of Plaintiff.

14 5) Each side shall bear its own fees and costs of suit.

15 6) Except as provided herein, all claims alleged in the First Amended Complaint
16 against Defendant are dismissed with prejudice.

17 7) This Injunction shall be deemed to have been served upon Defendant at the time
18 of its execution by the Court.

19 8) The Court finds there is no just reason for delay in entering this Injunction and,
20 pursuant to Rule 54(a) of the Federal Rules of Civil Procedure, the Court directs
21 immediate entry of this Injunction against Defendant.


22 9) The Court shall retain jurisdiction of this action to entertain such further
23 proceedings and to enter such further orders as may be necessary or appropriate to
24 implement and enforce the provisions of this Injunction.

25 10) The above-captioned action, shall, upon filing by Plaintiff of the Settlement
26 Agreement, Stipulation for Entry of Judgment and Judgment Pursuant to Stipulation,
27 and requesting entry of judgment against Defendant, be reopened should Defendant
28

1 default under the terms of the Settlement Agreement.

2 11) This Court shall retain jurisdiction over Defendant, for a period of ten (10) years
3 from the date of entry of this Consent Decree and Permanent Injunction on PACER,
4 pursuant to *Kokkonen vs. Guardian Life Insurance Corporation*, 511 U.S. 375 (1994),
5 for the purpose of making further orders necessary or proper for the construction or
6 modification of this consent decree and judgment; the enforcement hereof; the
7 punishment of any violations hereof; and for the possible entry of a further Judgment
8 Pursuant to Stipulation in this action.
