**ORDER GRANTING REQUEST
FOR ENTRY OF DEFAULT
AGAINST DEFENDANT DAVID
BOYD AS TRUSTEE OF
ANCESTRAL ACQUISITIONS
TRUSTS [18]**

7 The Court has not received an appropriate response to the August 5, 2014 Order
8 to Show Cause from Defendant David Boyd as Trustee of Ancestral Acquisitions
9 Trust. (*See* ECF No. 20.) As stated in the August 5, 2014 Order, only individuals
10 may represent themselves pro se. *See* L.R. 83-2.2.2 (“No organization or entity of any
11 other kind (including corporations, limited liability corporations, partnerships, limited
12 liability partnerships, unincorporated associations, trusts) may appear in any action or
13 proceeding unless represented by an attorney permitted to practice before this Court
14 under L.R. 83-2.1.”). Thus, Boyd was required to obtain an attorney to represent
15 Defendant David Boyd as Trustee of Ancestral Acquisitions Trust. He has failed to
16 do so. Accordingly, the Court **ORDERS** as follows:


- 17 • The Answer and Counterclaim filed on July 30, 2014 is **STRICKEN** as to
18 Defendant David Boyd as Trustee of Ancestral Acquisitions Trust *only*. (ECF
19 No. 17.) The Answer and Counterclaim thus applies only to individual
20 Defendant David Boyd.
- 21 • The Court also **GRANTS** Plaintiff Federal National Mortgage Association’s
22 Request for Entry of Default. (ECF No. 18.)
- 23 • Plaintiff Federal National Mortgage Association shall file a default-judgment
24 motion against Defendant David Boyd as Trustee of Ancestral Acquisitions
25 Trust **no later than Monday, September 22, 2014**.

26 This Order has no effect on the pending Motion to Dismiss Counterclaim,
27 which applies only to Defendant David Boyd as an individual. If Boyd has any doubt
28 concerning law or procedure, or has difficulty filing papers properly, he should

1 consult an attorney. If he cannot afford an attorney, he is hereby advised that there is
2 a Federal Pro Se Clinic located in the United States Courthouse at 312 N. Spring
3 Street, Room G-19, Main Street Floor, Los Angeles, California 90012. The clinic is
4 open for appointments on Mondays, Wednesdays, and Fridays starting at 9:30 a.m.
5 The Federal Pro Se Clinic offers free, on-site information and guidance to individuals
6 who are representing themselves in federal civil actions. Boyd is encouraged to visit
7 the clinic for advice concerning his case.
